## RELEASE AGREEMENT FORM

**I ACKNOWLEDGE THAT BY SIGNING THIS DOCUMENT, I AM RELEASING HOMELIFE ASSOCIATION, RIVER PARKS AUTHORITY, THE CITY OF TULSA, TULSA COUNTY, THE TULSA WHEELMEN BICYCLE CLUB AND OTHERS FROM LIABILITY. THIS RELEASE IS A CONTRACT WITH LEGAL CONSEQUENCES. I HAVE BEEN ADVISED TO READ IT CAREFULLY BEFORE SIGNING.**

In consideration of the acceptance of my application for entry in the above event, I hereby freely agree to and make the following contractual representations and agreements.

I acknowledge that participating in this event can be inherently dangerous and fully realize the danger of participating in such a race. **I FURTHER ACKNOWLEDGE AND AGREE THAT I FULLY REALIZE THE DANGERS OF PARTICIPATING AND FULLY ASSUME THE RISKS, ASSOCIATED WITH SUCH PARTICIPATION INCLUDING**, by way of example, and not limitation, the following: the dangers of collision with pedestrians, vehicles, other racers, and fixed or moving objects; the dangers arising from surface hazards, equipment failure, inadequate safety equipment, **THE RELEASED PARTIES' OWN NEGLIGENCE**, and weather conditions; and the possibility of serious physical and/or mental trauma or injury associated with athletic competition.

For myself, my heirs, executors, administrators, legal representatives, assignees, and successors in interest (collectively "Successors") **I HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, PROMISE TO INDEMNIFY AND NOT SUE** HOMELIFEASSOCIATION, RIVER PARKS AUTHORITY, THE CITY OF TULSA, TULSA COUNTY, AND THE TULSA WHEELMEN BICYCLE CLUB, the sponsors of this event, the organizer, property owners, law enforcement agencies, all public entities, special districts, and properties and their respective agents, officials, and employees, through or by which the event will be held (collectively, "the Released Parties") **FROM ANY** and all rights and **CLAIMS INCLUDING CLAIMS ARISING FROM THE RELEASED PARTIES' OWN NEGLIGENCE**, which I have or which may hereafter accrue to me and from any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of, my participation in or association with the event, or travel to or return from the event.

I agree it is my sole responsibility to be familiar with the race course, the Released Parties' rules, and any special regulations for the event. I understand and agree that situations may arise during the event which may be beyond the immediate control of the event officials or organizers, and I must continually ride so as to neither endanger myself nor others. I acknowledge that there may be protective equipment which would be appropriate for participation in this event including, but not limited to, a helmet which will protect against serious head injury. I accept responsibility for the condition and adequacy of any equipment that I use for this event. I also assume all responsibility and liability for the selection of any and all protective equipment that I wear during the event. **I SPECIFICALLY RELEASE AND INDEMNIFY HOMELIFE**

ASSOCIATION, RIVER PARKS AUTHORITY, THE CITY OF TULSA, TULSA COUNTY, AND THE TULSA WHEELMEN BICYCLE CLUB AND OTHERS OF AND FROM ANY AND ALL LIABILITY, IF ANY, THAT MAY ARISE IN THE EVENT I DO NOT WEAR PROTECTIVE EQUIPMENT THAT MIGHT BE APPROPRIATE FOR PARTICIPATION IN THE EVENT. I have no physical or medical condition which, to my knowledge, would endanger myself or others if I participate in the event.

I agree, for myself and my successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my successors assert a claim in contravention of this agreement, the asserting party shall be liable for the expenses (including legal fees) incurred by the other party or parties in defending, unless the other party or parties are finally adjudged liable on such claim for willful and wanton negligence. This agreement may not be modified orally, and a waiver of any provision shall not be construed as a modification of any other provision herein or as a consent to my subsequent waiver or modification.

I agree to allow the Released Parties and others to publish, distribute, or otherwise use any likeness or image of me, whether photographically, electronically, or otherwise created, and any audio tape of me (collectively, "images") for any legitimate reason connected to or arising out of Racing on the River, including without limitation, publicity, promotion, or media coverage of the event or any aspect of my participation in or preparation for the event. By executing the Release, I relinquish all rights to such images and to any compensation for publication or use of same.
